

Grimsby Power Inc. e-billing Contest

Rules and Regulations

By entering the Contest (defined below), entrants agree to abide by these Rules and Regulations and will be deemed to have received, understood and accepted these Rules and Regulations by participating in the Contest.

Grimsby Power Inc. (hereinafter "GPI") e-billing Contest ("the Contest") will run from 12:01 a.m. EST on August 1, 2017 until 11:59 p.m. on November 30, 2017 ("the Contest Period").

Prizes

Entry

No purchase is necessary, but your entry must be received by online entry during the Contest Period.

*New e-billing customers only.

Customers who are currently enrolled in "e-billing" listed above are not eligible for entry by that particular method. However a valid entry will be given should that customer enroll in the "**Pre-Authorized Debit Payment Plan**" and "**MyHydroEye TOU Portal**" that they currently are not enrolled in.

To constitute an entry, each sign up must be completed by the end of the Contest Period. In addition, each sign up shall be subject to approval and confirmation by GPI.

Any sign up not so approved or confirmed by GPI, or determined by GPI to be incomplete, inactive or otherwise ineligible, shall not constitute an entry into the Contest. The determination of approval, completeness, activity or ineligibility may occur after the end of the Contest Period.

Any other method of entry is void. Non-compliance with any entry procedure will result in disqualification. All entries must be received by 11:59 p.m. EST November 30, 2017 (the "Contest Closing Date").

If a business or commercial customer is selected as a winner, the business owner or officer will be assigned the prize for distribution at his/her sole discretion.

Contest excludes employees, agents and representatives of any of the following, and anyone with whom such persons are living (whether related or not) and a member of any such person's immediate family (regardless of where they live): Grimsby Power Inc. and its affiliated companies. The selected entrant will also be required to sign a declaration and release form ("the Release Form") confirming compliance with these Rules and Regulations, acceptance of the prize was awarded, without substitution and releasing GPI, its affiliates and respective shareholders, directors, officers, employees, agents, representatives, successors and assigns (collectively,

By entering the Contest, all entrants consent to the use, without compensation, of their name, city of residence, audio/video image, statements, and/or photograph in any related publicity. The use of an invalid email address will void the entry. Entrants using multiple email addresses to enter the Contest will be disqualified from the Contest. In the event of a dispute, entries will be deemed to have been submitted by the authorized account holder of the email address associated with the applicable GPI account. “Authorized account holder” is defined as the person who is assigned an email address by an internet provider or other organization (e.g. educational institute, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. If the identity of an entrant is disputed, the authorized account holder associated with the email account at the time of entry will be deemed the entrant. A selected entrant may be required to provide proof that he/she is the authorized account holder of the email address associated with the selected entry. The sole determinants of the time for the purposes of a valid entry in the Contest are the Contest server machine(s).
